RE: CS Ruling of July 20, 2018

Dear Mr. Gore,

Further to the findings of the CS review Panel dated July 20, 2018 and specifically regarding Item #7 of the panel review ruling, which reads as follows – *“Providing all conditions as outlined above in items 1 to 5 are satisfactorily met. The panel recommends the terms of Mr Gore’s license suspension be reviewed on October 1, 2018 and recommend that his probation period commence as at October 1, 2018, and expires on December 31, 2019.”*

As at October 1, 2018, we hereby confirm that for the period outlined Mr. Gore:

- Made payment of the applied fine in the amount US\$1,000 to the JMMC
- Completed one community service activity that being a school visit to Prospect Primary School in Manchester on September 17, 2018.
- Returned competition license MSF1676-18IC as requested to the JMMC CS
- Wrote letters of apology to the JMMC, TTASA, CMRA, CMRC and JRDC

We further acknowledge that presentation to participants of the JMMC Young Driver Training programme as stipulated was deferred by the JMMC.

In light of the foregoing, we are obliged to advise you that having reviewed your compliance of the stipulations as laid out the review panel directs that the terms of Mr Gore’s license suspension be amended as follows:

- Effective October 1, 2018 Mr Gore is granted a suspended sentence of his National license suspension. Therefore Mr Gore is able to participate in National competitions for the period October 1, 2018 to December 31, 2018.
- The probation period as previously stipulated to commence on January 1, 2019 shall now commence as at October 1, 2018, and expires on December 31, 2019.
- The CS Panel will further review the International suspension and will advise on same.
