Dear Mr. Baugh,

The Competition Subcommittee (CS) has concluded its review of proceedings associated with the protest filed by Mr. Nigel Wilmot at the JRDC Circuit Wheels on Fire event held on May 26, 2019 at Jamwest Speedway, Westmoreland.

Summary of review conclusions:

- \* Mr. Wilmot's protest was lodged within the time defined in the event ASR's. The ASR's stipulated a 60 minute period for which the results were Provisional, during which time competitors "*may bring any complaints or protests arising from the race itself*".
- \* The Stewards erred in ruling that the 55 minute submission time invalidated the protest.
- \* The Stewards erred in citing that personal cheques are unacceptable forms of payment, as no such regulations exist within the JRDC or JMMC regulations or event ASR.
- \* A conflict exists between JMMC regulations and the FIA international Sporting Code in regard to the necessity for citing the relevant regulations when writing a protest; JMMC regulations contain no such reference.
- \* Mr. Wilmot is correct in his assertion that Stewards may act on an Incident without a protest.

Therefore, the CS has found that the Event Stewards by their actions outlined above denied Mr. Wilmot Due Process after exercising his Right of Protest. The JMMC CS formally issue the penalty of a Reprimand of the Stewards, and caution the Event Stewards to exercise due diligence in judicial matters, so as to ensure that processes are accurately followed in accordance with event ASR's as well as the JMMC Regulations.
