DRIFTING - POINTS

10 Points deducted for striking course markers

10 points deducted for spinning out and continuing.

10 points deducted for any form of reversing for each occurrence.

10 points deducted for stopping.

20 points for hitting each flipper x 2

50 points for hitting the pendulum

50 points for Horse shoe

50 points for 720 score 0/50 MUST DRIFT

20 points for box 1 & box 2

50, 20 & 5 points for Park Box

300 points total

DEXTERITY - TIME

2 seconds added if hit any marker on the course

5 seconds added if miss scoring pointers (pendulum, flippers)

5 seconds added if hit markers in stop box

10 seconds added if hit front marker in stop box
