Date: December 8 , 2024

Location: Spot Valley Raceway

Start time: 9:00am

Type of event: Dirt Rally Sprint. 6 Stages Approximate 24km.

Technical Inspection: 7:00a.m. – 7:30a.m. All vehicles shall comply with the Mandatory Safety Requirements as specified in Section 6.1.1 of the JMMC Regulations. Mandatory Drivers equipment **MUST** be presented at Technical Inspection. Log Books must be presented at scrutineering. Note: Approved fire-retardant Race suits FIA 8856-2018 Standard (Per FIA Technical List No. 74 issued 2022); Helmets per FIA Technical List No. 25 & 69 and FHR per FIA Technical List No. 29, are mandatory for all competitors.

Drivers Meeting: 8:00 am, at the Official's tent.

Trophies: Awards will be given as per DRC Championship Regulations

License: ALL DRIVERS are required to have a minimum *JMMC National A Competition Driver's License* (National B for Rookies ONLY) to participate in the event. JMMC 2024 Competition License **MUST** be presented at Registration and Scrutineering.

Entries Open: Monday November 18, 2024

Entries Close: Sunday December 8, 2024 7:00am

Entry Fees: \$15,000. Must be paid on the morning of the event.

Results: Provisional Results will be posted to the Officials Notice Board within one (1) hour of the end of the Championship Run. Official Final Results shall be sent via email on Monday December 9, 2024.

Timing/Direction: Electronic timing equipment with Manual Stopwatch backup. The event will be formatted as a rally sprint by using sprint runs, which will be scored on overall accumulated time from all six (6) runs.

Special Note to all competitors:

1. Competitors who for any reason miss a single run or DNF a run but

are able to continue to complete the event will be given Bogey time for the missed/DNF run. ***Bogey time will be announced in the Drivers Meeting.***

2. Drivers who are late to the stage start will be given a 10 second penalty per stage.
