Competent Minors under the legal driving age must apply for a JMMC One Day Permit with the consent of their parent/guardian. Cost of one day permit is \$1,000.00 payable to the Jamaica Millennium Motoring Club

DRIFTING - POINTS Maximum 200

3 JUDGES

Judge 1 – STYLE - 60 points

Judge 2 – TRANSITION - 70 points

Judge 3 – ANGLE & LINE - 70 points

Quarter, Semi and Finals will be TANDEM – Lead & Chase format

After both runs the judges will review both runs (LEAD & CHASE) and make their decision (IF RUNS ARE CLOSE JUDGES CAN ASK FOR RERUN)

LEAD DRIFTER – The lead drifter is expected and will be SCORED as per qualifying run, enter all ZONES.

CHASE DRIFTER – The chase drifter is expected to mimic the LEAD DRIFTER (will be SCORED based on PROXIMITY, ANGLE). If the lead driver has poor angle, the judges do not want the chase driver to mimic the poor angle, but show dominance by bettering the angle, where possible.

JUDGES DECISIONS ARE FINAL.
